



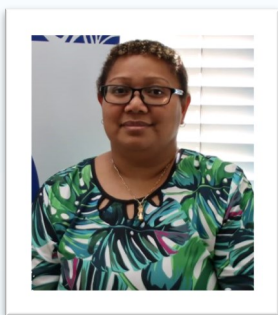

# April - June Activity Highlights

## Pacific's First Vessel Boarding and Seizure Training Facility Opens in Fiji

**T**wenty one Customs, Immigration and Fisheries Officers from nine Pacific Island Countries helps to enhance their skills in underway vessel boarding and search methods and improving efforts in combatting Transnational Organised Crimes and Illegal, Unreported and Unregulated fishing. Training was held at the first Pacific Vessel Boarding and Search Training Facility at the Fijian Naval Base in Togalevu, Fiji. This was constructed through the support of JICA and the Global Maritime Crime Programme (GMCP) of the United Nations Office on Drugs and Crime (UNODC) and in partnership with the Fiji Maritime Surveillance and Rescue Coordination Centre (FMSRCC).

# April - June Activity Highlights

## Workshop on Post Clearance Audit and Risk Management



Our Head of Secretariat, Nancy T Oraka launched the Post Clearance Audit & Risk Management Workshop in Nadi, Fiji in May. We are grateful to our partners from Japan & New Zealand Customs for their generous support. This workshop is about strengthening customs operations and trade facilitation in our Blue Pacific. The workshop was an important capacity building activity under OCO's Strategic Priority Area Four – Revenue Management and Compliance. There was a total of 13 participants from 11 OCO member countries including CNMI, Cook Islands, Fiji, French Polynesia, Guam, Niue, Palau, PNG, Solomon Islands, Tuvalu and Vanuatu. Post Clearance Audit is one of the customs centric measures of the World Trade Organisation Trade Facilitation Agreement and when applied in a risk-based manner allows Customs to target resources effectively and work in partnership with the business community to improve compliance levels and facilitate trade.

## IMPACT Continues With Gap Analysis

The IMPACT Project has successfully conducted legal and technical gap analyses on the WTO TFA, RKC, and iEPA in 15 PACP countries. The findings have been presented to country heads, marking a crucial step forward in our project.

# April - June Activity Highlights

## OCO & AUSTRAC discuss possible activities through PFIC



OCO's Head of Secretariat and Operations Team met with Australian Transaction Reports and Analysis Centre (AUSTRAC) Liaison officer, Ms. Mandy Liang based at the Australian High Commission in Suva, to discuss possible collaborative activities through a regional partnership with the Pacific Financial Intelligence Community (PFIC).

This networking opportunity would help strengthen the relationship between Customs administrations and Financial Intelligence Units in the region. OCO has been invited to present at a PFIC Tradecraft Tuesday session in July to share the role of OCO.

## Pacific Security Conference Charts Course for 2050

The Oceania Customs Organisation (OCO) Secretariat and members joined the Pacific Regional and National Security Conference from 24-26 June 2024, hosted by the Pacific Islands Forum Secretariat in Suva, Fiji. Organised by the Pacific Security College, the three-day event was followed by the Forum Officials Committee Subcommittee on Regional Security meeting on 27 June 2024. Twelve regional members, including Australia, Fiji, New Zealand, and Pacific island nations, sent 15 participants to the conference. The objective was to strategically explore and identify potential futures for the Blue Pacific by 2050, focusing on collective actions to enhance regional resilience and preparedness. The conference provided a crucial platform for collaborative dialogue on emerging regional security challenges and opportunities.



## 25th Pacific Immigration Development Community (PIDC)



At the 26th Pacific Immigration Development Community (PIDC) Regular Annual Meeting (RAM) held in Honiara, Solomon Islands from June 25th to 27th, 2024, OCO was represented by Operations Manager, Laisa Naivalurua. Ms. Naivalurua delivered presentations addressing critical issues, including:

- Maritime Border Challenges: Emerging Maritime Trends in the Pacific
- Countering Serious Organised Crime: People Smuggling, Human Trafficking, and Drugs

She also met Mr. Peter Hughes, Controller of the Solomon Islands Customs and Excise Division (SLICED), their discussions focused on capacity building needs and challenges faced by SLICED.

## PNG Records High Revenue Collection

Prime Minister Hon. James Marape has applauded PNG Customs for recording high growth rates over the past five years. Prime Minister Marape, while commenting on PNG Customs performance report for May 2024, said despite the tough economic times facing the country, PNG Customs was doing exceptionally well. "PNG Customs has recorded K3.9 billion in revenue collections for last year (2023), which is the highest under any government," said PM Marape. With the continuing increase in the revenue collections, PNG Customs said it is optimistic that it would meet the Government's projections for 2024 which is K4.25 billion.

## ***Rest in Love Mr Jose Antonio Fatima Abilio***

We offer our condolences to Timor Leste Customs Authority after the sad passing of its head, Jose Antonio Fatima Abilio. Mr Abilio was a dedicated civil servant who transformed Timor Leste's Customs Authority. A father of six, he held key roles including Vice Director of Planning and Chief of Staff of the Finance Minister's Office during his civil service career.

Appointed Customs Commissioner in 2014, Mr. Abilio modernised the agency by simplifying customs codes, aligning with international standards, and developing 30 Standard Operating Procedures. He implemented a single window system involving 13 government agencies and navigated significant challenges, including trade management during the COVID-19 pandemic.

Known for his commitment to transparency and economic development, he worked to increase Timor Leste's prosperity through strategic customs reforms. Despite the challenges of leading a young nation's customs service, Mr. Abilio remained focused on institutional improvement and public service. He will be remembered for his significant contributions to Timor Leste's governmental infrastructure and his dedication to national progress.
