26th OCO Annual Conference



The 26th OCO Annual Conference themed "Strengthening Partnerships for Dynamic Solutions and a Future-ready Blue Pacific" was held at the Edgewater Resort & Spa in Rarotonga, Cook Islands, from July 29th to 31st, 2024. The conference was opened by 'The Honorable Prime Minister' for Cook Islands, Mark Brown, who in his opening speech emphasised the urgency of regional cooperation in safeguarding the Pacific's future.



Outgoing OCO Chairperson and Head of Cook Islands Customs, Ms. Rachel Goodwin stressed the importance of embracing digital transformation to enhance capabilities and adapt to evolving landscapes of trade and security. Ms. Nancy T. Oraka, Head of the Oceania Secretariat emphasised the importance of collaboration among member states and partners.

Pacific Nations Grapple With Counterfeit Goods and Intellectual Property



M s Nancy T. Oraka, Head of Secretariat (pictured) of the Oceania Customs Organisation (OCO), addressed the Pacific Colloquium on Consumer Protection, painting a stark picture of the region's struggle with counterfeit goods and the complexities of intellectual property rights (IPR). "The trade in counterfeit and illicit goods poses a grave threat," Ms. Oraka said, citing the economic damage, risks to public safety. She emphasised the growing recognition of IPR's vital role in fostering innovation and economic growth, particularly in a region increasingly connected to the global marketplace. Ms. Oraka also acknowledged the unique hurdles faced by Pacific Island nations, including limited resources and the need to reconcile modern IPR regimes with traditional knowledge systems. Despite these challenges, she pointed to significant progress: modernised laws, participation in international treaties, and a burgeoning interest in geographical indications to protect culturally significant products like kava.

The delicate balance between IPR protection and access to essential knowledge, especially in healthcare and education, remains a key concern. Ms. Oraka stressed the need for further research and data collection to inform policy decisions.

Highlighting the partnership between OCO and the United States Patent and Trademark Office, Ms.

Oraka lauded their joint efforts in legislative reform and public awareness. Her closing message was a call to action, urging collective efforts to build a Pacific region where intellectual property rights are upheld, innovation thrives, and the well-being of its citizens is secured.

OCO & MSG Renew Agreement

The Oceania Customs Organisation (OCO) renewed its resourcesharing agreement with the Melanesian Spearhead Group (MSG), marking a significant step towards a safer and more prosperous region. The collab promises to bolster efforts in combating illicit trade, transnational crime, and border security threats. The agreement facilitates the exchange of critical resources, including information, technology, training programs, and personnel, between OCO and MSG member countries: Fiji, Vanuatu, Papua New Guinea, and the Solomon Islands. By pooling expertise and strengthening cooperation, Oceania's customs administrations aim to present a united front against the increasingly complex challenges facing the region. "This renewed partnership underscores our commitment to regional

security and economic stability," said OCO Head of Secretariat, Nancy T Oraka. "By working together with the MSG, we can enhance our collective capacity to address shared threats and protect our communities." In his opening remarks, Director General of the MSG Secretariat, Leonard Louma, said that the MSG collectively has a corre-

By simplifying these processes, OCO aims to reduce the administrative burden on businesses, freeing up valuable time and resources for growth and development. This workshop was conducted under the IMPACT Project which is a project funded by European Union. The Gap Analysis for 15 PACP countries completed by OCO, in collaboration with UNCTAD, on customs-related World Trade Organisation Trade Facilitation Agreement was presented at the workshop. During the workshop, participants were given an opportunity to finalise Summary Action Plans developed from the Gap Analysis for their respective administrations.

Handling Chemical Weapon Threat

he Oceania Customs Organisation (OCO), in partnership with the Organisation for the Prohibition of **Chemical Weapons** (OPCW), concluded a regional conference aimed at enhancing customs control over the trade and transit of toxic chemicals.



Held in Port Vila, the conference addressed growing concerns over the potential misuse of dual-use chemicals and sought to bolster regional cooperation in preventing their diversion. Key priorities included:

Optimising customs procedures: Developing more effective methods for detecting and intercepting suspicious shipments. Sharing best practices: Exchanging strategies for mitigating the risks associated with non-state actors acquiring these chemicals. R

Enhancing regional cooperation: Strengthening information sharing and collaborative efforts among Oceania Customs Administrations. OCO remains dedicated to working with its partners to build a safer and more secure Oceania, where the threat of chemical weapons is effectively mitigated.
